2026 HP Rifle Program - NRA International Fullbore Midrange Prone Rifle Matches

NRA Sanctioned Matches: Competitors' scores and NRA registration fees are sent to NRA Competitions at year's end and count toward your NRA classification.

Dates: Saturday May 30th Saturday June 13th
Saturday July 18th

Location: SSA grounds, 5426 Footville-Richmond Rd. Richmond Township, Ohio 44003.

Directions: I-90 to SR11 exit 228.
South on SR11 to SR 307. East on 307 to SR193.
North on SR193 to Footville-Richmond Rd.
East approx. 4 miles on Footville-Richmond Rd. to club gate, on the South side of the road.

Time to arrive: Front gate will open from 12:00 PM until 12:45 PM for sign in and squadding.

Squadding: Sign in and squadding is at the building just inside the front gate between 12:00 Noon and 12:45 PM with final adjustments made on the 300yard line. Shotmarker electronic targets are planned; however, final determination will be by the match director. If pits are used all competitors must present themselves when their relay is called, and report for his/her duty in the pits before they seal to be scored in this event.

Time of firing: Firing will begin at 1:15PM from the 300-yard line.

Entries at the match: Until 12:45 PM

Entries by mail: None.

Rules: Current NRA International Fullbore competition rules apply.

Eligibility: SSA & Non SSA members are welcome. All entrants of this match should be experienced marksmen. Competitors must sign an annual liability release agreement. All rifles shall have at least a known 200 yard zero.

Fees: If only entered for this match - \$10 for SSA members; \$25 for non-members; Juniors (NRA rule

2.3) are \$10. If entered in that day's Mid Range Match, this match is an additional \$10 for Adults, \$5 for Juniors and SSA Members. A single per annum \$5 league fee will be collected at your first match for all league matches.

Rifles Allowed: Target Rifle and International Target Rifle per NRA Fullbore Rules 3.3.5 and 3.3.6. F Class Rifles per NRA F-Class Rules 3.1. Service Rifle and Match Rifle per NRA High Power Rules 3,1 and 3.3. Any rifle not conforming to Fullbore rules will have their scores reported as NRA Mid Range. Per NRA rules "The use of compensators or muzzle brakes is prohibited."

Ammunition: Competitors must provide their own ammunition. No incendiary or tracer ammo is permitted.

Sights: Metallic sights or telescopic sights, based on rifle, per NRA rules

Target: MR-63, MR-65, and MR-1.
MR-63FC, MR-65FC and MR-1FC for F-Class

Sighting shots: Two convertible sighting shots are allowed prior to each match.

"Convertible Sighters" means that, at the competitor's option, he or she may elect to keep either the second sighter or the first and second sighter as record shots. If the competitor elects to take the first sighter, he or she must take the second sighter as a record shot.

Course of fire:

Match 1 Two convertible sighting shots and 15 shots for record at 300 yards on the MR-63/MR-63FC target

Match 2 Two convertible sighting shots and 15 shots for record at 500 yards on the MR-66/MR-65F target

Match 3 Two convertible sighting shots and 15 shots for record at 600 yards on the MR-1/MR-1FC target

Match 4 The match winner: Aggregate of matches 1-3

Pair Firing will be utilized; time limit will be 45 seconds for all shots. (25 ½ minutes per relay)

Shotmarkers will be set on 7 second delay, recent shot only

Note - If your rifle does not have a known zero, you must notify the line officer.
